SCOPE OF WORK

1.0 SCOPE OF WORK:

- **SPECIFICATION FOR 40 MT MECHANICAL CRANE:**
 - Minimum 40 MT CAPACITY mechanical crane .
 - CRANE SHOULD BE IN GOOD WORKING CONDITION.
 - Crane should be provided with--operator & maintenance staff.

1.2 Hire charges should be for 12 hrs. daily operation with fuel, lubricants ,mob & demob charges.

2.0 DEPLOYMENT DETAILS, CONTRACT PERIOD AND DAILY WORKING HOURS

2.1 The Crane with operator, helpers shall remain available for minimum cumulative 12 Hours/day.

2.2 A callout order with mobilization notice shall be issued to Contractor for the requirement of the Crane.The Contract Duration Period for Crane Deployment shall be as per callout order.

2.3 Mobilization shall be done with in 6 hours from the issuance of mobilization notice. Mobilization shall be deemed complete from the time of arrival of crane at location with good equipment, manpower & material.

3.0 The contractor and his personnel shall co-operate within all DIL personnel, DIL's Customer, Customer's Consultants and all other Contractors, coordinating the Crane movements with others and work in a manner that shall not delay or hinder the progress of work of the project.

4.0 Towards fulfillment of the relevant Safety norms, the Contractor is required to submit valid test certificate for the crane to be deployed at site. If required On deployment, Load test is to be conducted at site for which necessary load materials will be provided by DIL free of cost.

5.0 In case there is a total failure of the crane, the contractor should replace the same and bring substitute Crane immediately . In the case of Contractor's failure to do so, DIL shall make alternative arrangements at the risk and cost of the contractor.

6.0 Necessary Insurance Coverage for the Crane including Third Party liability and for the workmen (covering Workmen's Compensation Act) engaged by the Contractor shall be Contractors responsibility.

- 7.0** Any loss or damage to DIL or Customer's property due to negligence of the crew employed by the contractor is attributable to the Contractor. DIL shall not be responsible for any accident/injury to the Contractor's Crew/staff during operation or otherwise. Contractor has to assume full responsibility of the safety of their crew/staff and to comply with the security/safety regulations of DIL and others at site.
- 8.0** All the statutory requirements as called for by the Labour Laws and other statutory authorities are to be met by contractor and proof of compliance should be made available to DIL.
- 9.0** Crane will be mobilized along with required accessories like jacks, slings, shackles & helper etc.

- 1 The day rate quoted shall be all inclusive with mobilization & demobilization and remain firm throughout contract period including extended period (if any).
- 2 Applicable service tax will be paid extra at actual by the Company.
- 3 **TERMS OF PAYMENT:** The Contractor shall submit the invoice on demobilization of crane. Invoices shall be paid within 45 days from the date of receipt of invoice along with complete documents in all respect accompanied by DIL site engineer.
- 4 Additional working hours on any specific day shall be payable on pro-rata basis after one shift.
- 5 Above mentioned number of days are estimated only. However payment shall be done at actual utilization.
